He co-founded the virtual network of international FOI advocates www.freedominfo.org, served as founding co-chair of the public interest coalition OpenTheGovernment.org, and also served on the first steering committee of the international Open Government Partnership. He was a frequent guest on the former Colbert Report.

The annual conference will feature panelists and speakers on topics like *How to Build a Better Mouse Trap: More user friendly dispute resolution of open government matters, Dealing with Broad Requests, and Threats to Transparency: A Legislative Update.* Guest panelists include, among others, former State Attorney General Rob McKenna, open government attorney Michele Earl-Hubbard, and WCOG President, Toby Nixon.
