Exempts from disclosure proprietary information submitted to the Department of Health under the act. This is a reasonable exemption consistent with similar exemptions for proprietary business information.

*Comments:* Creates an airport infrastructure loan program for local and small airports to acquire loans to fund capital projects. Exempts from PRA disclosure any confidential financial or commercial information submitted by loan applicants.

*Comments:* Establishes the democracy is strengthened by casting light on spending in elections act of 2018 (the Washington state DISCLOSE act of 2018). Closes campaign finance disclosure loopholes and requires the disclosure of contributions and expenditures by nonprofit organizations that participate significantly in state elections. CONCERN: The bill must clarify that simply writing about or commenting about a candidate, ballot measure, or issue, such as an editorial or policy analysis, does not constitute an in-kind contribution or independent expenditure for or against a campaign.

CONCERNS: It is not clear how they can be added to the voter registration database "when they will be eighteen years of age before the next election" and also keep their information confidential until they are actually 18.

Requires the growth management hearings board to collect an assessment of two hundred fifty dollars from a requester of a review by the board. Exempts the following from public inspection and copying under the public records act: Records submitted to the attorney general's office for review by the ombuds as part of a claim and records created by the department of commerce related to the claim. *Comments:* Exempts all information about regulation of explosives under RCW 70.74 from disclosure. CONCERN: This will make the regulators of explosives completely unaccountable to the public as to whether or how well they are doing their jobs. It will make it impossible for people concern about public safety to learn anything about where explosive are stored or produced around them. This exemption should not be so broad.

*Comments:* Exempts from disclosure personal information of persons who make claims of sexual harassment if the person requests it be kept confidential. CONCERN: Section 2 creates civil liability for a person who requests and obtains such information and uses it to harass, stalk, intimidate, or threaten -- but this kind of provision regarding misuse of information does not belong in the PRA, and should be placed in the appropriate statute barring such use of information.

*Comments:* Modifies the public records act to: (1) Exempt the following from the definition of agency: The judicial branch or the state legislature, including individual offices of state legislators, legislative caucuses, or other offices within the state legislature; (2) Provide a definition for "public records" for purposes of the legislature; (3) Provide exemptions from the definition of "public records" for purposes of the legislature; and (4) Require the secretary of the senate and the chief clerk of the house of representatives to serve as the public records officer for the party caucuses and each state legislative office. Concerns include that the bill does not retroactively apply to existing records, that it defines some records as not being public records rather than simply exempting them from disclosure, and the range of documents excluded from disclosure.

*Comments:* Provides a definition of "intimate image," for purposes of inspection and copying exemptions in the public records act, with regard to body worn camera recordings. Eliminates the June 1, 2019, expiration date of chapter 10.109 RCW regarding the use of body worn cameras. Concerns include the continued requirement that redaction costs be paid by requesters, and the treatment of body cam recordings differently from other public records with regard to penalties, attorney fees, and court costs.

Concerns include the prohibition on awarding of attorney fees to plaintiffs and the limitations on which actions are considered null and void if improperly adopted without adequate notice.

*Comments:* Requires every executive state officer and agency, except for institutions of higher education, to report to the public disclosure commission the following information for employees or contractors employed or contracted with the executive state officer or agency whose position is funded, in whole or in part, by private sources: (1) The name of the employee or contractor; (2) The scope of the work performed; (3) The annual gross salary; (4) The name of any private sources from which funding for the salary is received and the amount of the funding; and (5) If the private source is a nonprofit organization, a list of the organization's top fifty donors and donors that have contributed more than fifty thousand dollars to the organization, based on a certain amount of time. Requires the public disclosure commission to make that information available for public use or inspection and allow direct access to the information on its web site.
